## Management Discussion of Fund Performance

### Investment Objective and Strategies

The investment objective of the Ninepoint Silver Bullion Fund (the “Fund”) is to provide a secure, convenient alternative for investors seeking to hold silver.

As part of its investment strategy, the Fund:

- invests primarily in unencumbered, fully allocated silver bullion and silver certificates;
- may invest a portion of its assets in cash, money market instruments and/or treasury bills; and
- may invest in derivatives, such as currency forward contracts, for hedging purposes only.

Sprott Asset Management LP is the subadvisor for the Fund.

### Risk

The risks of investing in the Fund are described in the Fund’s simplified prospectus. The Fund is suitable for those investors who want exposure to the capital appreciation potential of silver and who want to maintain a high level of liquidity in their investments with a high tolerance for risk and volatility and have a medium to long-term investment horizon. There were no significant changes to the investment objective and strategies that affected the Fund’s overall level of risk during the reporting period.

### Results of Operations

The Fund, Series A, returned -7.9% in the first half of 2023, versus spot silver, which decreased by 7.0% in Canadian dollar terms. In U.S. dollar terms, spot silver decreased by 4.9%. The spot price of silver was \$22.77 an ounce (in U.S. dollar terms) as at June 30, 2023 compared to a price of \$23.95 an ounce as at December 31, 2022.

Gold carried over its strong 2022 close into 2023, posting a gain of 5.2% through the first half. This was despite bullion ETFs continuing to liquidate both gold and silver. However, silver did not fare quite as well, declining 4.9% through the first half. Perhaps the most important reason for the difference in silver’s performance vs that of gold was the lack of systematic buying to support the liquidation of ETFs. Gold was a beneficiary of strong central bank buying which carried over from 2022. While central banks have been buyers of gold, we have not seen any evidence of silver purchases by central banks. Through the first half of the year, silver ETFs sold ~2.6 million ounces of silver while gold ETF holdings declined by ~1.2 million ounces.

The silver production market is currently in a deficit, according the Silver Institute, as demand outstrips supply. This is expected to benefit silver prices in the longer run, especially as above ground stockpiles are depleted and as investor demand returns. The Fund was fully invested in silver bullion during the period.

The Fund’s total net asset value decreased by 10.7% during the period, from \$90.7 million as at December 31, 2022 to \$81.0 million as at June 30, 2023. This change was predominantly due to net redemptions of \$2.8 million and unrealized depreciation in the value of investments of \$6.6 million.

### Recent Developments

There were no material changes to the investment strategy and features of the Fund during the period ended June 30, 2023. The Manager actively monitors the positioning of the Fund’s portfolio for changes in current market conditions and the economic environment.

## Related Party Transactions

### MANAGEMENT FEES

The Fund pays a management fee to the Manager at an annual rate of 1.30% for Series A units, 0.85% for Series D and Series F units and as negotiated by the unitholders of Series I. The management fee is calculated and accrued daily based on the daily net asset value of the applicable series of the Fund and is paid monthly. For the period ended June 30, 2023, the Fund incurred management fees of \$504,377 (including taxes). The breakdown of the services received in consideration of the management fees, as a percentage of management fees, is as follows:

Out of the management fees that the Manager received from the Fund, the Manager paid trailer commissions of \$9,297 during the period ended June 30, 2023 to Sightline Wealth management, an affiliate of the Manager.

### OPERATING EXPENSES

The Fund pays its own operating expenses, which include, but are not limited to, audit, legal, custodial, trustee, filing and administrative expenses as well as unitholder reporting costs. The Manager pays certain of these expenses on behalf of the Fund and then is reimbursed by the Fund. At its sole discretion, the Manager may waive or absorb a portion of the operating expenses of certain Funds. Amounts waived or absorbed by the Manager are reported in the Statements of Comprehensive Income. Waivers or absorptions are at the Manager's discretion and can be terminated at any time without notice. The Manager did not absorb any expenses during the period ended June 30, 2023.

### OTHER RELATED PARTY TRANSACTIONS

The Fund relied on the approval, positive recommendation or standing instruction from the Fund's Independent Review Committee with respect to any related party transactions.

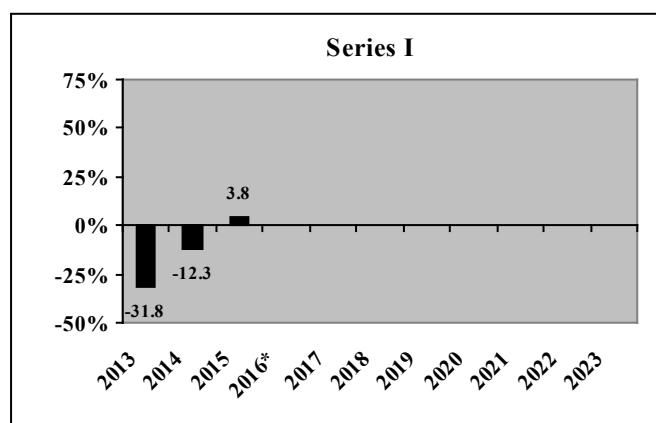
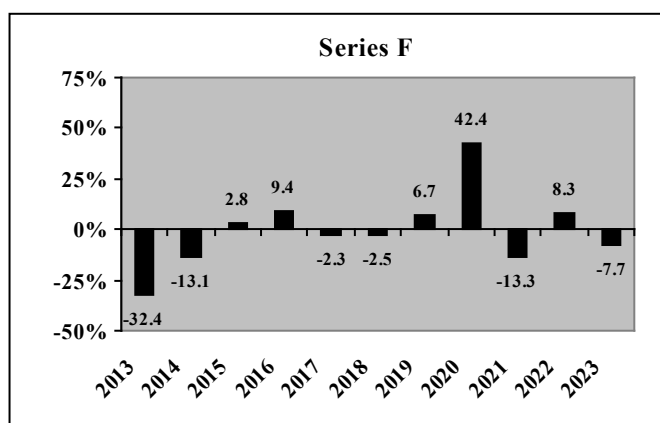
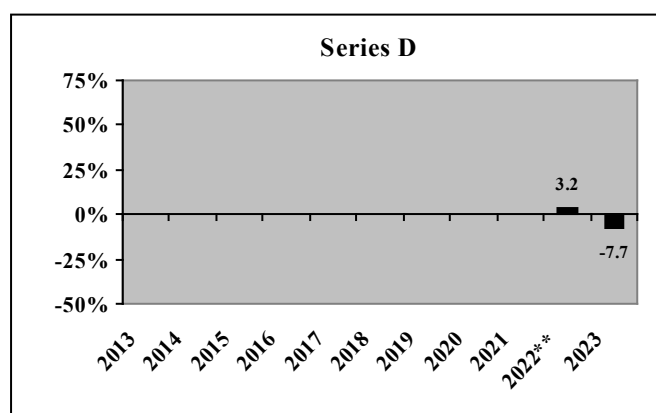
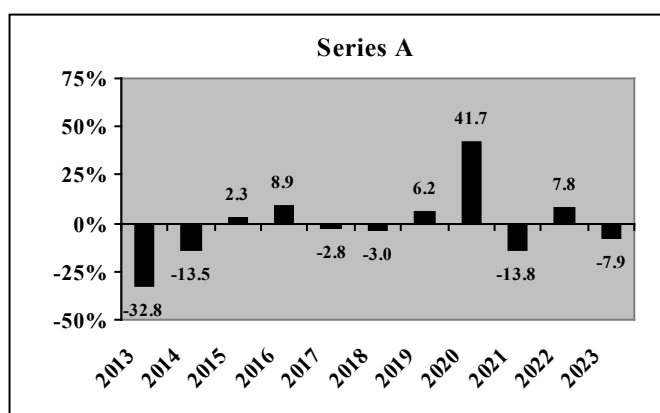
4 The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. The portfolio turnover is expressed as a non-annualized percentage.

## Past Performance

The indicated rates of return are the historical total returns including changes in unit values and assume reinvestment of all distributions in additional units of the relevant Series of the Fund. These returns do not take into account sales, redemption, distribution or optional charges or income taxes payable by any unitholder that may reduce returns. Please note that past performance is not indicative of future performance. All rates of returns are calculated based on the Net Asset Value of the particular Series of the Fund.
