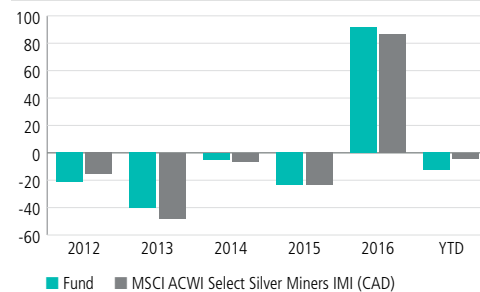
WHY INVEST IN SPROTT SILVER EQUITIES CLASS?

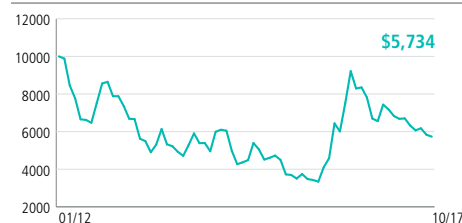
CALENDAR YEAR RETURNS (%)¹
