### Ninepoint Enhanced Equity Class – Series I Shares

This document contains key information you should know about Ninepoint Enhanced Equity Class (“Fund”) Series I shares. The Fund is a class of shares of Ninepoint Corporate Class Inc. You can find more details in the Fund’s simplified prospectus. **Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.**

Subject to securityholder approval, Ninepoint Partners LP proposes to change the investment objective of the Fund effective on or about August 7, 2020 to permit the Fund to obtain exposure to the performance of the S&P 500 Index, or a successor or replacement index and through the use of option strategies seek to moderate the volatility of that performance. In conjunction with the proposed investment objective change, once approved and implemented, the name of the Fund is expected to change to Ninepoint Risk Advantaged U.S. Equity Index Class. The U.S. dollar purchase option will also cease to be available on or about August 7, 2020. Investors holding shares purchased under the U.S. dollar purchase option will receive redemption proceeds and distributions in Canadian dollars effective on or about August 7, 2020.

On February 18, 2020, the management fee of Series I of the Fund was reduced from a maximum of 2.00% to a maximum of 1.80%. While the MER of Series I disclosed in this document is 0.43%, the current MER is lower due to the reduction in the management fee.

#### WHAT DOES THE FUND INVEST IN?


The Fund seeks to provide long-term capital growth by investing primarily in Canadian and U.S. equity securities. The Fund’s aggregate exposure to foreign securities will not exceed approximately 49% of its assets.

#### HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility.”

#### RISK RATING

Ninepoint Partners LP has rated the volatility of this Fund as **low to medium**.

This rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.


Like most mutual funds, this Fund does not have any guarantees. You may not get back the amount of money you invest.

**HOW HAS THE FUND PERFORMED?**

This section tells you how Series I shares of the Fund have performed in the past 7 calendar years. Returns are after fund expenses have been deducted. These expenses reduce the Fund's returns.

**Year-by-year returns**

This chart shows how Series I shares of the Fund performed in the past 7 calendar years. The Fund dropped in value in 1 of the 7 calendar years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



**Best and worst 3-month returns**

This table shows the best and worst returns for Series I shares of the Fund in a 3-month period over the past 7 calendar years to March 31, 2020. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

As at March 31, 2020, a person who invested \$1,000 in Series I shares of the Fund on its inception would now have \$1,287.61. This works out to an annual compound return of 3.23%.

**WHO IS THIS FUND FOR?**

The Fund is suitable for those investors seeking long-term capital growth and a core Canadian equity fund that seeks to provide some downside protection through the use of option strategies and tactical changes to the amount of equity exposure. Investors should be comfortable with low to medium investment risk and a long-term investment horizon.

**⚠️** Don't buy this Fund if you need a steady source of income from your investments.

**A WORD ABOUT TAX**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live, the type of earnings (i.e., income or capital gains), and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series I shares of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

### 1. Sales Charges

There are no sales charges or commissions payable to your representative's firm for Series I shares of the Fund.

### 2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As of December 31, 2019, the Fund's expenses were 0.92% of its value. This equals \$9.20 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and his or her firm provide to you.

Ninepoint Partners LP may pay a trailing commission to your representative's firm. The rate is negotiated by us and your representative's firm.

### 3. Other Fees

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

FEE	WHAT YOU PAY
<b>Management Fee</b>	The series' annual management fee is negotiated by the investor and paid outside the Fund. It would not exceed 1.8%.
<b>Switch Fee / Conversion Fee</b>	A fee of 0-2.0% of the value of the shares you wish to switch or convert may be charged by your representative's firm, as negotiated with your representative.
<b>Short-Term Trading Fee</b>	Ninepoint Partners LP may impose a short-term trading fee payable by the shareholder to the Fund of up to 1.5% of the aggregate net asset value of the shares redeemed if such shares are redeemed or switched within 20 days of their date of purchase or switch. For purposes of this short-term trading fee, shares will be considered to be redeemed on a first-in, first-out basis. If Ninepoint Partners LP detects excessive trading of the shareholder's shares in the Fund within 90 days of purchasing or switching them, it reserves the right to charge an additional 3.0% of the net asset value of the shares.
<b>Registered Tax Plan Fees</b>	No fee is charged to open, close or administer a registered tax plan administered by Ninepoint Partners LP. However, for other registered tax plans holding other investments in addition to securities of a Ninepoint mutual fund, an annual trustee fee may apply payable to the administrator of the plan.

## WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities legislation in your province or territory.
