This document contains key information you should know about Ninepoint Diversified Bond Class (“Fund”) Series D shares. The Fund is a class of shares of Ninepoint Corporate Class Inc. You can find more details in the Fund’s simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

The Fund will be merged into a substantially similar mutual fund structured as a trust on or about December 10, 2021. The Independent Review Committee has approved the merger and investors of the Fund as of October 1, 2021 have been provided with notice of the merger.

WHAT DOES THE FUND INVEST IN?


The Fund aims to provide income. It seeks a similar return to its underlying fund, Ninepoint Diversified Bond Fund, by investing substantially all of its assets in securities of that fund. The underlying fund invests primarily in debt and debt-like securities of corporate and government issuers from around the world.

The charts below give a snapshot of the underlying fund’s investments on September 30, 2021. The underlying fund’s investments will change.

HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility.”

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to

Ninepoint Partners LP has rated the volatility of this Fund as **low**.


Like most mutual funds, this Fund does not have any guarantees. You may not get back the amount of money you invest.

HOW HAS THE FUND PERFORMED?

This section tells you how Series D shares of the Fund have performed in the past 2 calendar years. Returns are after fund expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how Series D shares of the Fund performed in the past 2 calendar years. The range of returns change from year to year and can help you assess how the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series D shares of the Fund in a 3-month period over the past 2 calendar years and to September 30, 2021. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Best return	3.71%	June 30, 2020	Your investment would rise to \$1,037.14.
Worst return	-1.57%	March 31, 2021	Your investment would fall to \$984.33.

Average return

As at September 30, 2021, a person who invested in Series D shares of the Fund on its inception would now have \$1,092.86. This works out to an annual return of 2.68%.

WHO IS THIS FUND FOR?

The Fund is suitable for investors who seek the potential for income and who want to share in the opportunities offered by high yielding debt securities issued by companies and countries from around the world. The Fund is suitable for investors with a low tolerance for risk and volatility and a medium to long-term investment horizon.

■ Don't buy this series if you need a steady source of income from your investments.

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live, the type of earnings (ie. income or capital gains), and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series D shares of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence your dealer firm to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. Sales Charges

There are no sales charges or commissions payable to your discount broker for Series D shares of the Fund.

Annual Rate (as a % of the Fund's value)

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As of June 30, 2021, the Fund's expenses were 1.34% of its value. This equals \$13.40 for every \$1,000 invested.

More about the trailing commission

There is no trailing commission payable to your representative's firm by Ninepoint Partners LP in respect of Series D shares of the Fund.

3. Other Fees

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

FEE	WHAT YOU PAY
Switch Fee / Conversion Fee	A fee of 0-2.0% of the value of the shares you wish to switch or convert may be charged by your discount broker, as negotiated with your discount broker.
Short-Term Trading Fee	Ninepoint Partners LP may impose a short-term trading fee payable by the shareholder to the Fund of up to 1.5% of the aggregate net asset value of the shares redeemed if such shares are redeemed or switched within 20 days of their date of purchase or switch. For purposes of this short-term trading fee, shares will be considered to be redeemed on a first-in first-out basis. If Ninepoint Partners LP detects excessive trading of the shareholder's shares in the Fund within 90 days of purchasing or switching them, it reserves the right to charge an additional 3.0% of the net asset value of the shares.
Registered Tax Plan Fees	No fee is charged to open, close or administer a registered tax plan administered by Ninepoint Partners LP. However, for other registered tax plans holding other investments in addition to securities of a Ninepoint mutual fund, an annual trustee fee may apply payable to the administrator of the plan.

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities legislation in your province or territory.
