The trailing commission payable to dealers on Series A and Series AS units was reduced from 1.00% to 0.50%, and the maximum trailing commission payable to dealers on Series I units was reduced from a maximum of 1.00% to a maximum of 0.50%. These changes are more fully described in Amendment No. 1 to the simplified prospectus of the Fund.
