This document contains key information you should know about Ninepoint Return Advantaged U.S. Equity Index Class (“Fund”) Series D shares. The Fund is a class of shares of Ninepoint Corporate Class Inc. You can find more details in the Fund’s simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

This Fund is an alternative mutual fund. It has the ability to invest in asset classes or use investment strategies that are not permitted for conventional mutual funds. The specific strategies that differentiate the Fund from conventional mutual funds include the increased use of derivatives for hedging and non-hedging purposes; increased ability to sell securities short; and the ability to borrow cash for investment purposes. These strategies will be used in accordance with the Fund’s investment objective and strategy however, during certain market conditions they may accelerate the risk of loss or a decrease in the value of your investment.

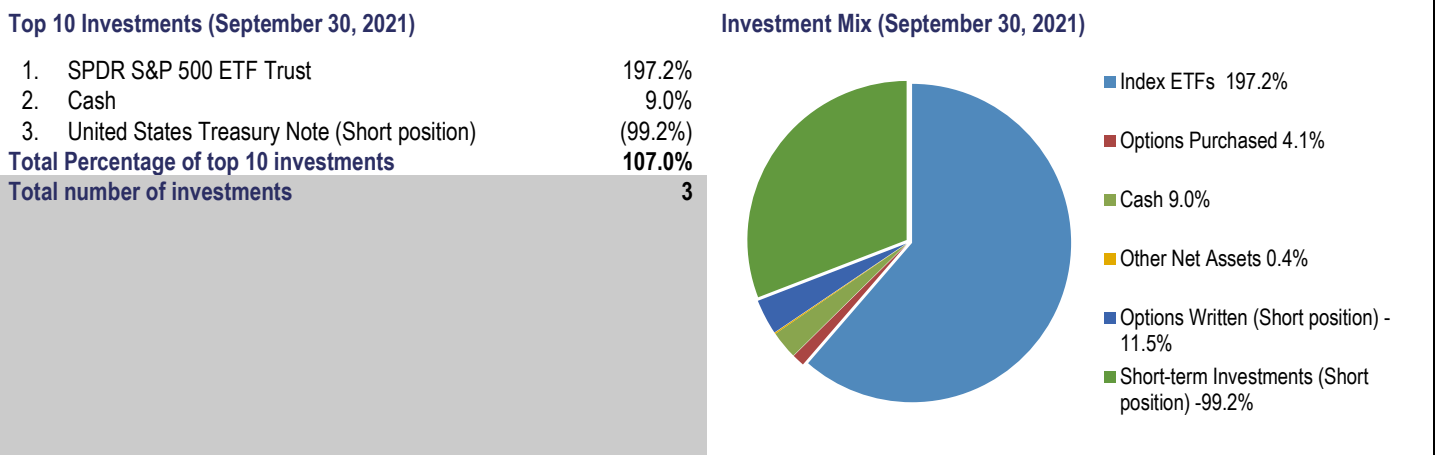
The Fund will be merged into a substantially similar mutual fund structured as a trust on or about December 10, 2021. The Independent Review Committee has approved the merger and investors of the Fund as of October 1, 2021 have been provided with notice of the merger.

WHAT DOES THE FUND INVEST IN?

The Fund’s investment objective is to obtain leveraged exposure to the performance of the S&P 500 Index, or a successor or replacement index (the “Index”) and through the use of option strategies seek to offer investors higher returns than the Index, but with similar volatility. The Fund may use derivatives, borrow cash and sell securities short. The maximum aggregate exposure to short selling, cash borrowing and derivatives used for leverage will not exceed 300% of the Fund’s net asset value, calculated on a daily basis.

The charts below give a snapshot of the Fund’s investments on September 30, 2021. The Fund’s investments will change.



HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility.”

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

Ninepoint Partners LP has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

HOW HAS THE FUND PERFORMED?

WHO IS THIS FUND FOR?

The Fund is suitable for those investors seeking long-term capital growth and a core U.S. equity fund that seeks to provide some downside protection through the use of option strategies and tactical changes to the amount of equity exposure.

A WORD ABOUT TAX

In general, you’ll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live, the type of earnings (i.e., income or capital gains), and whether or not you hold the Fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your Fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you could pay to buy, own and sell Series D shares of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence your dealer firm to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. Sales Charges

There are no sales charges or commissions payable to your discount broker for Series D shares of the Fund.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up of the management fee, operating expenses and trading costs. The series' annual management fee is 0.80% of the series' value. Fund expenses of this series have not been provided because no shares of this series are currently outstanding.

More about the trailing commission

There is no trailing commission payable to your representative's firm by Ninepoint Partners LP in respect of Series D shares of the Fund.

3. Other Fees

You may have to pay other fees when you buy, hold, sell or switch shares of the Fund.

FEE	WHAT YOU PAY
Switch Fee / Conversion Fee	A fee of 0-2.0% of the value of the shares you wish to switch or convert may be charged by your discount broker, as negotiated with your discount broker.
Short-Term Trading Fee	Ninepoint Partners LP may impose a short-term trading fee payable by the shareholder to the Fund of up to 1.5% of the aggregate net asset value of the shares redeemed if such shares are redeemed or switched within 20 days of their date of purchase or switch. For purposes of this short-term trading fee, shares will be considered to be redeemed on a first-in, first-out basis. If Ninepoint Partners LP detects excessive trading of the shareholder's shares in the Fund within 90 days of purchasing or switching them, it reserves the right to charge an additional 3.0% of the net asset value of the shares.
Registered Tax Plan Fees	No fee is charged to open, close or administer a registered tax plan administered by Ninepoint Partners LP. However, for other registered tax plans holding other investments in addition to securities of a Ninepoint mutual fund, an annual trustee fee may apply payable to the administrator of the plan.

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities legislation in your province or territory.
