## Management Discussion of Fund Performance

### Investment Objective and Strategies

The objective of Ninepoint FX Strategy Fund (the “Fund”) is to generate long term total returns by investing globally in FX futures on a long/short basis. To achieve the Fund’s investment objective, the Fund will utilize several investment trading methodologies at the standard level of risk to invest in foreign currency futures utilizing a Bayesian statistical model to identify current drivers of currency returns. The Fund will use derivatives, which may introduce leverage into the Fund. The Fund may also borrow cash and sell securities short. The Fund’s maximum aggregate exposure to short selling, cash borrowing and derivatives used for leverage must not exceed 300% of the Fund’s net asset value, calculated on a daily basis.

As part of its investment strategy, the Fund may:

- invest a portion of its assets in cash, money market instruments and/or treasury bills; and
- invest in derivatives including options, futures or forward contracts, and permitted to use derivatives by securities regulations for hedging and non-hedging purposes.

P/E Global LLC is the subadvisor for the Fund.

### Risks

The risks of investing in the Fund are described in the Fund’s simplified prospectus. This Fund is suitable for those investors seeking exposure to capital appreciation of investing in fluctuations in the prices of currencies and wanting to maintain a high level of liquidity in their investments. This Fund is suitable for investors with a medium to high tolerance for risk and have a long-term investment horizon.

### Results of Operations and Recent Developments

The Fund, Series A returned 2.6% in the first half of 2021, while its benchmark, the Credit Suisse Managed Futures Hedge Fund Index, returned 3.3%.

During the first half of 2021, the global economy began to exhibit notable recovery from COVID-19 based on the vaccine rollout, continued large-scale fiscal expansion and aggressive monetary policy support. These combined policies further supported equity markets and overall economic health. The vaccine rollout in the U.S. quickened pace in the first half of 2021, leading to higher U.S. growth expectations, and in turn, supporting the dollar in Q1. Afterwards, the Euro-zone’s vaccine rollout began to catch up in Q2, denting some of the Q1 USD gains. Market focus then shifted to the timing of when the Fed may taper asset purchases and the path/timing of rate hikes. During the June Federal Open Market Committee meeting, the Fed signaled that they may raise rates earlier than previously expected. This caught some market participants off-guard, sending the USD higher to end Q2.

The forementioned macro-economic events had a positive impact on performance during this period. The main factors driving FX positioning included the short end of the yield curve, where the sub-advisor believes countries with a steeper yield curve look more attractive, and economic surprise, where European currencies are less attractive. The portfolio was positioned such that the sub-advisor remained long the U.S. Dollar, due to stronger growth in the U.S. versus other parts of the world. Low yielding currencies, such as the Euro, Japanese Yen, and the Swiss Franc, remained less attractive. The portfolio was well positioned as long positions in the U.S. Dollar positively contributed to performance due to the vaccine rollout and the Fed’s shift toward tapering talk as the economy rebounded.

In terms of positions that contributed most to the mandate’s performance, the top two were short positions in the Australian Dollar and the Euro. However, it is important to note the significant investor crowding in long Australian Dollar and Euro positions, which typically presents more risk.

In contrast to the top two performers, the Canadian Dollar and Gold detracted from the mandate. This was due to the Bank of Canada turning more hawkish than the Fed in 1H21 and a rebound in oil prices. Gold also fell as the U.S. dollar rebounded and real yields rose.

The portfolio positions were adjusted in conjunction with macro-economic events. The portfolio’s short Euro position increased as significant investor crowding in long Euro positions is often a sign of short-term risk. The portfolio’s long Gold position was also reduced as U.S. real yields bottomed in January.

The Fund’s net asset value decreased by 38.5% during the period, from \$9.0 million as at December 31, 2020 to \$5.6 million as at June 30, 2021. This change was predominately due to net redemption of \$3.5 million.

## Related Party Transactions

### MANAGEMENT FEES

The Fund pays a management fee to the Manager at an annual rate of 2.05% for Series A units, 2.25% for Series A1 units, 1.75% for Series D and Series F1 units, 1.55% for Series F and Series QF units, and as negotiated by the unitholders for Series I. Effective April 30, 2021, the management rate of Series D shares was reduced from 2.00% to 1.75%. The management fee is calculated and accrued daily and is paid monthly based on the daily net asset value of that series of the Fund. For the period ended June 30, 2021, the Fund incurred management fees (including taxes) of \$66,641. The breakdown of the services received in consideration of the management fees, as a percentage of management fees, is as follows:

Out of the management fees that the Manager received from the Fund, the Manager paid trailer commissions of \$1,075 during the period ended June 30, 2021, to Sightline Wealth Management, an affiliate of the manager.

### PERFORMANCE FEES

The Fund also pays the Manager a performance fee equal to a percentage equal to 20% of the difference by which the return in the net asset value per unit of the applicable series the first business day of the calendar quarter (or from inception if any series commences on a date other than the beginning of the quarter) to the last business day of the calendar quarter exceeds the high water mark per unit of such series. For each series of the Fund, the “high water mark” means the greater of (i) the initial net asset value per unit, or (ii) the net asset value at the end of the most recent calendar quarter for which a performance fee was paid after giving effect to all distributions in, and payments of performance fees for, such calendar quarter. The net asset value includes all expenses and is calculated before income and capital gains are distributed. The performance fee is calculated and accrued daily and paid quarterly on a calendar quarter basis. For the period ended June 30, 2021, the Fund did not accrue incentive fees.

### OPERATING EXPENSES

The Fund pays its own operating expenses, which include, but are not limited to, audit, legal, custodial, filing and administrative expenses as well as shareholder reporting costs. The Manager pays certain of these expenses on behalf of the Fund and then is reimbursed by the Fund. At its sole discretion, the Manager may waive or absorb a portion of the operating expenses of the Fund. Amounts waived or absorbed by the Manager are reported in the Statements of Comprehensive Income. Waivers or absorptions can be terminated at any time without notice. For the period ended June 30, 2021, the Manager absorbed \$6,112 of expenses.

### OTHER RELATED PARTY TRANSACTIONS

The Fund relied on the approval, positive recommendation or standing instruction from the Fund’s Independent Review Committee with respect to any related party transactions.

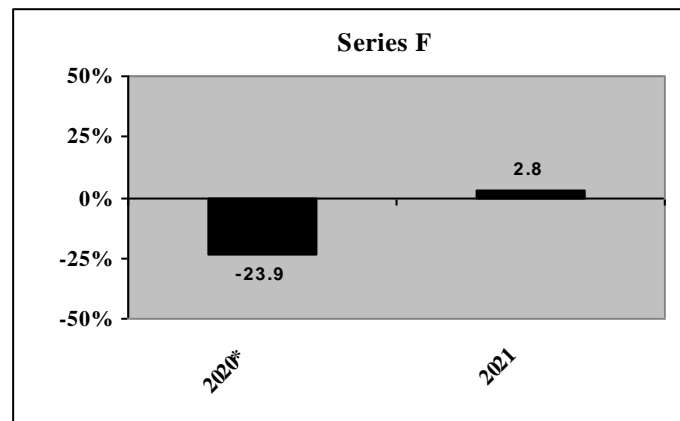
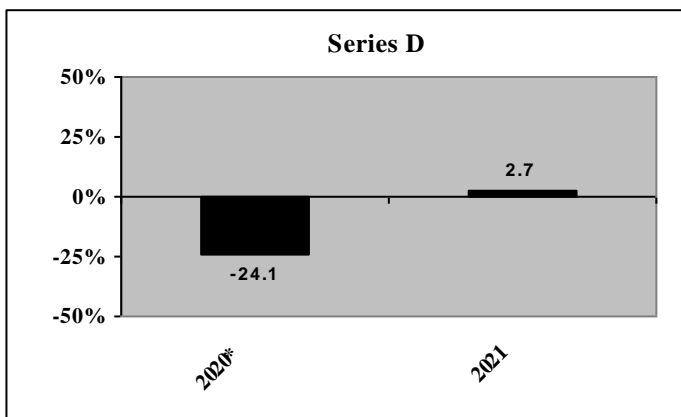
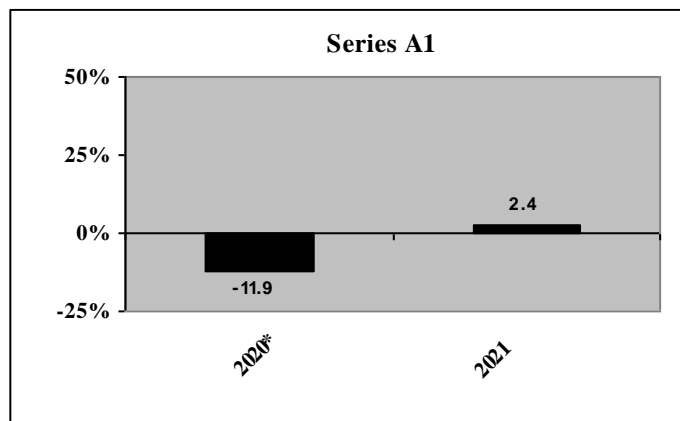
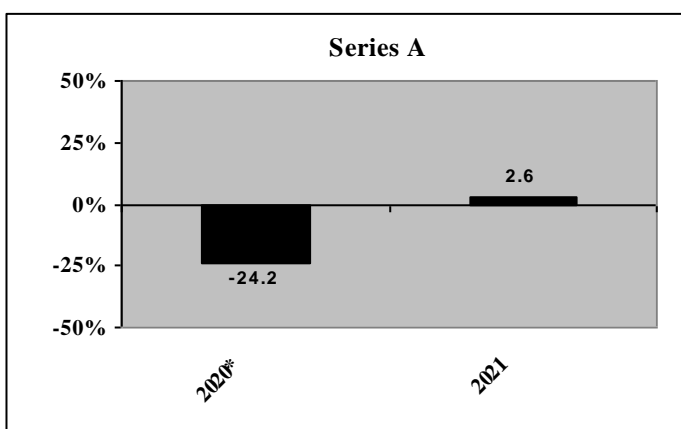


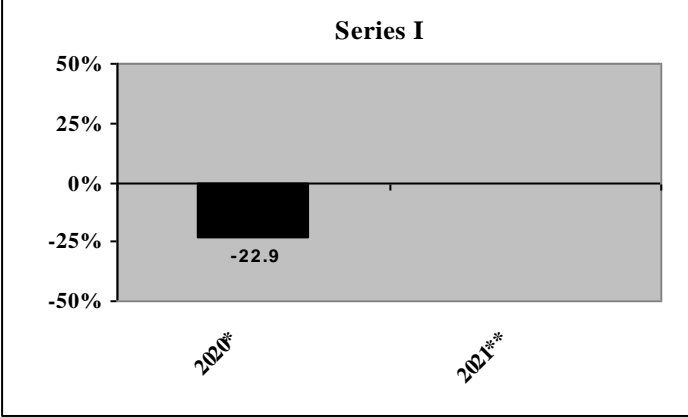
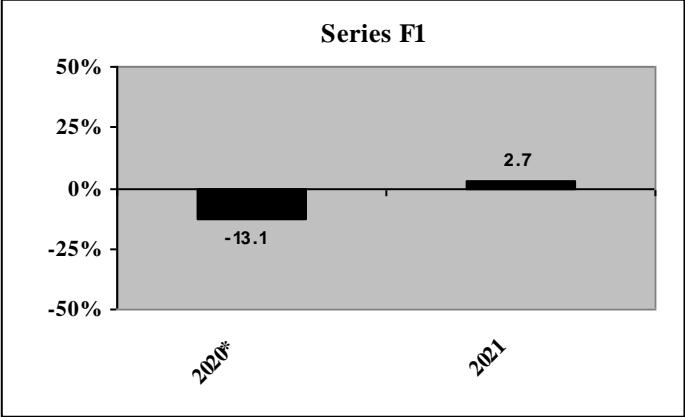
## Past Performance
