Interest and dividend income are generated through an overlay strategy consisting of a core portfolio of laddered securities, in conjunction with an interest rate protected portfolio of securities. We target the best opportunity within a company's capital structure – investment grade bonds, high yield, loans, convertible bonds, preferred shares or equities. We emphasize risk management throughout the investing cycle – capital preservation is of paramount importance to us. Our fund does not replicate an index, our goal is to consistently generate positive results.

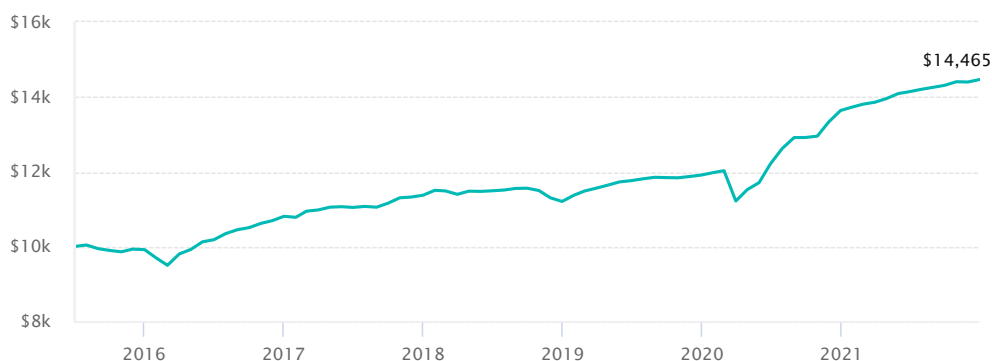
